# AGREEMENT # OF CREATIVE COOPERATION

"5" May 2021

Georgia, Kutaisi

Kutaisi University (Georgia, Kutaisi) on behalf of the President Lasha Kandelakishvili, hereinafter referred to as UNIK, on the one part, and Central Ukrainian National Technical University (Ukraine, Kropyvnytskyi), on behalf of Rector Volodymyr KROPIVNYI, hereinafter referred to as CUNTU, hereinafter referred to as "PARTIES" have herein agreed as follows:

## 1. GENERAL PROVISIONS

Taking into account mutual interests of the PARTIES in establishing international cooperation in development of education and scientific research, the present agreement has following basic purposes:

realization of joint international projects; coordination of scientific research;

- realization of students' exchange;

- organization of internship programmes for teachers.

#### 2. SUBJECT OF THE AGREEMENT

The subject of the present agreement is the creation of favourable conditions for cooperation in realization of joint international projects, carrying out scientific research, realization of students' exchange, organization of internship programmes for teachers. According to this agreement the PARTIES are engaged to cooperate in the following directions:

- improvement of the processes of educational, scientific and methodological work, perfection of methodology and quality of education;
- participation in international conferences held by the PARTIES:
- assistance in exchange of informational database of the PARTIES, rendering possibilities to
  publish the results of scientific research in scientific collection of works which are published
  by UNIK and CUNTU;
- preparation of joint international projects to get grants, including according ERASMUS+;
- assistance in students' exchange between UNIK and CUNTU:
- creation of the conditions for internship programmes for professors and students on the bases of UNIK and CUNTU.

#### 3. TERM OF AGREEMENT

- 3.1. The present Agreement comes into force the moment of its signing by both PARTIES. The term of agreement is 5 years. The present Agreement may be automatically continued for every next year, if neither PARTY claimed about the intention to terminate the present Agreement.
- 3.2. The present Agreement may be terminated by the initiative of any PARTY with written notification according to the reasons of irrationality of further cooperation, and in the case of impossibility of carrying out joint activity.

#### 4. ALTERATIONS TO THE AGREEMENT

The terms of the present Agreement have equal legal effect for both PARTIES and may be changed on mutual concordance with obligatory compilation of a written document.

### 5. OTHER TERMS OF AGREEMENT

- 5.1. The present Agreement was made up and signed in duplicate, in Russian and in English which have equal legal effect.
  - 5.2. The present Agreement does not anticipate any financial obligations.
- 5.3. Any disagreements between PARTIES are settled with the help of negotiations and mutual agreement that anticipate observance of mutual interests.
