The World Social Capital Monitor is a worldwide open access Social Goods survey for citizens. The World Social Capital Monitor is a partnership project within the United Nations Sustainable Development Goals (UN SDG) since 2016: https://sustainabledevelopment.un.org/partnership/?p=11706

In order to collect data for the annual World Social Capital Monitor in the Ukraine, the parties agree to the following:

- 1) CUNTU will contribute to conducting the annual Social Capital Monitor (Ukraine: Social Goods Monitor) of Ukraine together with the Basel Institute. CUNTU will cover regions and towns of Ukraine, which will be indicated on the basis of separate annexe to the signed agreement.
- 2) All data entries are collected in the online databank through the portal of the World Social Capital Monitor: https://trustyourplace.com/?lang=ukr. Results from other sources (e.g. offline interviews) shall be inserted in the same database. The data can be used by Basel Institute for research and publications without any limit.
- 3) CUNTU shall receive the survey results in Excel format, and CUNTU can use and publish the results for own purposes without any limit.
- **4)** Basel Institute shall include and publish the results within the World Social Capital Monitor and name CUNTU as a partner of the World Social Capital Monitor.
- 5) Both parties will feature the cooperation partnership on their websites and in their country reports.



- 6) Basel Institute is applying for funding for the World Social Capital Monitor. The costs of CUNTU to conduct the annual Monitor are estimated in 4 times per year in local currency. The costs will be annually adapted to the National inflation rate of the Ukraine. In case of funding, the costs of CUNTU will be transferred to the following bank account: UA303052990000025301035100764
- 7) The duration of the cooperation is five years in order to create a timeline of five annual surveys.

The undersigned parties hereby agree to cooperate in good faith, and in accordance with the laws of Switzerland.

The parties have caused this Cooperation Agreement to be executed in two copies on the dates indicated below, effective as of the date indicated above.
